

Hand baggage allowance

The following hand baggage policy applies to the remaining bmi routes with a BD prime flight code and number.

Customers may take either one or two pieces of free hand baggage on board (depending on fare type) which must be a maximum size of 55x40x23cm, plus one personal item.

- Business 2 pieces
- Economy 1 piece

bmi Gold and Silver Diamond Club members are not permitted any additional hand baggage. Infants are not entitled to an allowance.

Hand baggage must have a **maximum length of 55cm**, **width of 40cm and depth of 23cm**. These dimensions include wheels, handles, side pockets, etc. If hand baggage exceeds this size, passengers will be asked to return to check-in and check the bag into the hold.

Passengers must be able to lift their cabin bag unaided into the overhead locker.

Please note, an exception to the above applies on flights from Damascus where airport authorities limit hand baggage to 8kg for Economy and 10kg for Business Class.

In addition, passengers may take into the cabin one personal item such as a small handbag, purse, small briefcase, laptop (in a thin satchel) or baby-changing bag. Personal items are accepted at bmi's discretion.

Cabin baggage allowance amongst carriers may vary when interlining and this remains at the discretion of the onward carrier

Liquids in hand baggage

Where possible customers should put all liquid items in their hold baggage. This includes water and other drinks, creams, sprays, pastes and gels. If liquid is to be carried on to the aircraft your customers must ensure they adhere to current regulations.

A small amount of liquids are allowed through security screening if:

- The liquid is in a container with a capacity no greater than 100ml (or equivalent)
- The containers are all contained within one closed transparent re-sealable plastic bag (such as a re-sealable freezer bag or zip top bag) which itself must not exceed 1 litre in capacity (approximately 20cm x 20cm).

- The contents of the plastic bag fit comfortably and the bag is completely closed
- The plastic bag should be taken out of your cabin bag and placed in a tray for x-ray screening. In this case 'liquids' include gels, pastes, lotions, liquid/solid mixtures and the contents of pressurised containers, e.g. toothpaste, hair gel, drinks, soups, syrups, perfume, deodorant, shaving foam, aerosols, mascara, etc.
- In addition to the liquids permitted in one transparent re-sealable bag you can take the following onboard:
- Electrical equipment including laptops, mobile phones, MP3 players, portable music and DVD players, digital and film cameras, video cameras all larger electrical equipment will need to be removed from your cabin baggage and x-ray screened separately
- Essential medicines in liquid form sufficient and essential for the flight in quantities less than 50ml (e.g. diabetic kit), as long as verified as authentic items must be removed from the bag and placed in a tray and screened separately
- Solid cosmetics
- Baby milk and liquid baby food (the contents of each bottle or jar must be tasted by the accompanying passenger) are permitted in the cabin bag.
